When you leave a legacy gift to the **Saint Louis Crisis Nursery**, you are building on 34 years of protecting children from child abuse and neglect, and strengthening families for generations to come.

The Crisis Nursery works by **preventing** instances of child abuse and neglect **before** they happen. When parents are faced with a crisis, or there is a threat to their child's safety—homelessness, family violence, mental health concerns, or overwhelming parental stress—there are 5 Nursery locations to which they can turn for help, and 10 Outreach Centers ready to provide crisis counseling and basic needs assistance.

The Crisis Nurseries operate 24 hours per day, 7 days a week, every day of the year, without exception.

Many of our kids are dealing with serious trauma and need a safe place where they can once again just be kids. Each year, nearly **5,000 children are nurtured and kept safe** at the Crisis Nursery. While there, they are given a medical exam, take part in Art & Play Therapy, receive nutritious meals and snacks, and get clothes and books of their own to take home.

Legacy gifts are crucial to ensure that the Crisis Nursery is always there for children to help build strong and resilient families for the future.


